Sources of Drinking Water

The sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land or through the ground, it dissolves naturally-occurring minerals and, in some cases, radioactive material, and can pickup substances resulting from the presence of animals or from human activity.

Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk. Contaminants that may be present in source water include:

- Microbial contaminants, such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations, and wildlife.
- Inorganic contaminants, such as salts and metals, which can be naturally-occurring or result from urban storm water runoff, industrial or domestic wastewater discharges, oil and gas production, mining, or farming.
- Pesticides and herbicides, which may come from a variety of sources such as agriculture, urban storm water runoff, and residential uses.
- Organic chemical contaminants, including synthetic and volatile organic chemicals, which are by-products of industrial processes and petroleum production, and can also come from gas stations, urban storm water runoff, and septic systems.
- Radioactive contaminants, which can be naturally-occurring or be the result of oil and gas production and mining activities.

In order to ensure that tap water is safe to drink, EPA prescribes regulations which limit the amount of certain contaminants in water provided by public water systems. FDA regulations establish limits for contaminants in bottled water which must provide the same protection for public health.

Contaminants may be found in drinking water that may cause taste, color, or odor problems. These types of problems are not necessarily causes for health concerns. For more information on taste, odor, or color of drinking water, please contact the system's business office.

You may be more vulnerable than the general population to certain microbial contaminants, such as Cryptosporidium, in drinking water. Infants, some elderly, or immunocompromised persons such as those undergoing chemotherapy for cancer; persons who have undergone organ transplants; those who are undergoing treatment with steroids; and people with HIV/AIDS or other immune system disorders, can be particularly at risk from infections. You should seek advice about drinking water from your physician or health care providers. If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. We are responsible for providing high quality drinking water, but we cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested. Lead and Copper

Definitions:

Water Quality Test Results

Notice of Water Quality Violations and Compliance

The City had two notices of violation or non compliance dealing with water testing requirements. They are identified below along with the corrective efforts.

- 1. April 22, 2013 Rejection of Water Sample for Routine Testing: the testing lab called and informed the city that the testing bottle had a crack in it so the sample was rejected. The City resubmitted the routine sample the same day and the second sample was accepted.
- 2. June 18 & 19, 2012 Rejection of a Water Sample at a Well: the City had to replace a well motor after a lightning strike. The sample on the 18th was not marked correctly, with a designation of "Construction" instead of "Special". The second sample showed E. Coli. The City further flushed and treated the well until the sample passed. The well was not put into service until the water quality met state requirements.

Use of Chlorine as a Disinfectant

The City uses chlorine as a disinfectant. The 2012 average levels of disinfectant residuals are as follows:

1st Quarter – 1.86 mg/L

2nd Quarter – 1.90 mg/L

3rd Quarter – 1.90 mg/L

4th Quarter – 1.83 mg/L

The lowest result for a single sample was 0.40 mg/L during the 4th Quarter of 2012. The highest result for a single sample was 2.83 mg/L during the first quarter of 2012. The maximum residual disinfectant level (MDRL) is 4 mg/L. The City of Pilot Point's maximum residual disinfectant level goal (MRDLG) is 2 mg/L. The unit of measure is milligrams per liter (mg/L). The source of Chlorine used by the City is 150 lbs. steel cylinders purchased from DPC Industries, 106 W. Industrial Blvd., Cleburne, TX 76033.
